Dear President Negron,

Thank you for outlining your vision of an appropriate implementation of the will of the voters, who supported the landmark Amendment 2 ballot measure with an overwhelming 71% approval. I agree that the implementation of Amendment 2 must promote an open and competitive market to ensure patient access to the marketplace.

In my proposed legislation on the matter, Senate Bill 614, I presented my vision to accomplish this objective. While the Legislature took a different approach than the measures I proposed, I believe we can benefit from revisiting some of this proposed legislation's core principles to promote an open and competitive marketplace in the medical marijuana implementation process.

The Senate should agree that the drive of implementation legislation must be patient focused, not the interests of existing license holders. To promote this, I propose we address the following issues:

- Vertical integration should be avoided, as it may cause prices to rise and creates gaps in product availability to patients. Allowing a horizontally integrated regulatory framework is necessary to provide the flexibility needed to promote specialization and robust competition that will drive down product prices and maximize consumer choice.
- Local governments must play a role in determining the number of dispensaries and their locations within their communities.
- Arbitrary limitations on the number of MMTC licenses should be avoided. Doing this would restrict competition, establish high barriers to entry, and violate our principles of free and open markets. The appropriate number of MMTC licenses should be determinant upon market demand.
