This is a request for public records from the Governor of the State of Florida. This request has been made pursuant to Article I, Section 24 of the Florida Constitution, and Chapter 119, Florida Statutes.

At this time, I am requesting copies of the following public records:

- Copies of phone records (not limited to, but including call logs, text messages, and voicemails) from the phone account Governor Rick Scott gave out to healthcare executives for hurricane emergency related issues.
- Other non-publicly available numbers, email accounts, or other modes of communication the Governor or other state agencies distributed or used related to Hurricane Irma.

As used herein, the term “public records” “means all documents, papers, letters, maps, books, tapes, photographs, films, sound recordings, data processing software, or other material, regardless of the physical form, characteristics, or means of transmission, made or received pursuant to law or ordinance or in connection with the transaction of official business by any agency.” See Section 119.011(12), Florida Statutes.

Should you deny this request, or any part thereof, please state in writing the basis for the denial, including the exact statutory citation authorizing the denial as well as the reason or reasons for the conclusion that the record is exempt or confidential.

Please advise me of the costs, if any, associated with the production of the requested public records. Also, please advise when I might expect that this request for public documents will be fulfilled.
